A PURPLE HEART RECIPIENT WHO IS ALSO A MEMBER OF MOPH, OR THE SPOUSE OF A PURPLE HEART RECIPIENT WHO IS A MEMBER OF MOPH, OR THE DIRECT LINEAL DESCENDANT (CHILD, STEP-CHILD, ADOPTED CHILD, GRANDCHILD OR STEP-GRANDCHILD) OF A PURPLE HEART RECIPIENT WHO IS A MEMBER OF MOPH, OR THE SPOUSE, WIDOW/WIDOWER, OR DIRECT LINEAL DESCENDANT AS DEFINED ABOVE OF A SERVICE MEMBER KILLED-IN-ACTION OR WHO DIED OF WOUNDS. - NEHA/AAS SCHOLARSHIP
- AWARD AMOUNT: \$2,250-\$2,500
- DEADLINE: MARCH
- QUALIFICATIONS: UNDERGRADUATE AND GRADUATE STUDENTS WHO ARE ENROLLED IN AN ACCREDITED COLLEGE OR UNIVERSITY, WITH A DEDICATED AND RECOGNIZED CURRICULUM IN EH SCIENCES, ARE ELIGIBLE TO APPLY FOR THE NEHA/AAS SCHOLARSHIP. THE PURPOSE OF THE SCHOLARSHIP PROGRAM IS TO ENCOURAGE EARLY COMMITMENT BY STUDENTS TO PURSUE A CAREER IN EH. THEREFORE, PREFERENCE IS GIVEN TO APPLICANTS WHO INDICATE THAT THEY INTEND TO WORK AS SANITARIANS/ENVIRONMENTAL HEALTH PROFESSIONALS AND NOT IN RELATED FIELDS.
- THE UNDERGRADUATE SCHOLARSHIP IS TO BE USED TOWARD THE TUITION AND FEES ASSOCIATED WITH EITHER THE JUNIOR OR SENIOR YEAR OF COLLEGE STUDIES. - QUALIFICATIONS: SONS/DAUGHTER OF ENLISTED MEMBERS OF THE NAVY, MARINE CORPS, AND COAST GUARD ON ACTIVE DUTY, RETIRED WITH PAY, OR DECEASED. APPLICANTS MUST HAVE A VALID DEPENDENT ID CARD. APPLICANTS SHOULD SHOW BASIS OF NEED FOR FINANCIAL ASSISTANCE, HAVE A SCHOLASTIC STANDING OF AT LEAST A 2.5 GRADE POINT AVERAGE AND BE A GRADUATE OF AN ACCREDITED HIGH SCHOOL OR IT EQUIVALENT OR WILL QUALIFY FOR GRADUATION PRIOR TO BEGINNING ELIGIBILITY FOR ASSISTANCE.
- FOUR INITIAL AWARDS WILL BE GIVEN FOR FRESHMAN STUDENTS WITH CONTINUATION NOT TO EXCEED THREE MORE YEARS. UNDERGRADUATE STUDENTS MAY APPLY FOR FOUR UPPERCLASSMEN AWARDS AND ANY VACANCIES THAT OCCUR IN THE RENEWAL GRANTS. SPECIAL SCHOLARSHIPS ARE GIVEN TO TWO MEDICAL STUDENTS, ONE STUDENT MAJORING IN SPECIAL EDUCATION AND FOUR AWARDS TO CHILDREN OF NWCA MEMBERS.

- SOCIETY OF DAUGHTERS OF THE UNITED STATES ARMY
- AWARD AMOUNT: \$1,500
- DEADLINE: MARCH
- QUALIFICATIONS: BE THE DAUGHTER, GRANDDAUGHTER, STEPDAUGHTER OR ADOPTED DAUGHTER OF A CAREER COMMISSIONED OR WARRANT OFFICER IN THE UNITED STATES ARMY WHO IS ON ACTIVE DUTY, RETIRED AFTER AT LEAST 20 YEARS ACTIVE DUTY SERVICE, WAS MEDICALLY RETIRED FROM ACTIVE DUTY OR DIED WHILE ON ACTIVE DUTY. HIGH SCHOOL SENIOR AND COLLEGE APPLICANTS MUST HAVE ACHIEVED A MINIMUM GRADE POINT AVERAGE OF 3.0 IN ACADEMIC WORK COMPLETED TO DATE. APPLICANTS MUST BE PLANNING TO ATTEND OR ARE CURRENTLY ATTENDING AN ACCREDITED POST-SECONDARY INSTITUTION IN A DEGREE PROGRAM FOR THE SUBSEQUENT ACADEMIC YEAR.

- DEADLINE: MARCH

- QUALIFICATIONS: BE A FRESHMAN IN THE 2020-2021 ACADEMIC YEAR AND ANTICIPATE ENROLLING AT A U.S. ACCREDITED COLLEGE/UNIVERSITY IN THE 2020-2021 ACADEMIC YEAR. HAVE A CUMULATIVE, UN-WEIGHTED GRADE POINT AVERAGE BETWEEN 3.7 AND 4.0 ON A 4.0 SCALE (OR EQUIVALENT). STUDENTS NOT ON A 4.0 GRADING SCALE MUST CONVERT THEIR GPA TO A 4.0 SCALE BEFORE SUBMITTING AN APPLICATION TO THE FOUNDATION. HAVE AT LEAST TWO REFERENCE LETTERS, ONE OF WHICH MUST BE FROM A CURRENT OR FORMER TEACHER IN AN ACADEMIC SUBJECT. SUBMIT AN ESSAY AS FURTHER DESCRIBED IN THIS APPLICATION. HAVE APPLIED TO A U.S. COLLEGE/UNIVERSITY, EITHER FULL-TIME OR SUBSTANTIAL PART-TIME, AND PLAN TO ENROLL IN A MINIMUM OF TWO TERMS FOR THE SCHOOL YEAR (VERIFIED BY SUBMITTING A COPY OF THE ACCEPTANCE LETTER FROM THE COLLEGE OR UNIVERSITY AS SOON SUCH ACCEPTANCE LETTER IS AVAILABLE). SUBMIT TO INTERVIEWS IN PERSON OR BY PHONE/SKYPE, IF REQUESTED.
