2022-2023 OVW Grant Year in Review

GRANT OBJECTIVE: The Office on Violence Against Women's Campus Violence Prevention Program assists colleges and universities in creating effective, comprehensive responses to domestic violence, dating violence, sexual assault, and stalking

GOALS ACCOMPLISHED BY SUBCOMMITTEE:

The Coordinated Community Response Team is composed of key personnel across campus who convene in one of five subcommittees to advance goals in the grant's strategic plan. Several goals are currently in progress within each committee. Here are this year's highlights:

- **Comprehensive Prevention**
 - Hosted Jennifer Landhuis from the Stalking Prevention, Awareness, and Resource Center (SPARC) to facilitate a stalking awareness and prevention workshop for the CCRT, faculty and staff, and students.
 - Adapted stalking training materials provided by SPARC for campus use.
 - Provided training on gender bias to program staff, campus and community partners, and law enforcement to enhance awareness of the needs of transgender and gender diverse students.
- **Victim Services**
 - Determined schedule for ATVP campus advocate to be on campus during term time.
 - Established private campus location for the advocate.
 - Hosted Dr. Robbie Paul, a Nez Perce tribal elder, to facilitate workshops on how to make medicine bags and traditional ribbon skirts.
- **Mobilizing Men**
 - Convened for a Mobilizing Men retreat and introduced 3 new members.
 - Initiated a social media campaign to publicize the committee's activities.
 - Held two "Boys Will Be Boys?" events exploring the nuances of masculinities.
 - Facilitated three Mobilizing Men sessions to Greek-affiliated men, including the Interfraternity Council, Fiji, and Phi Delta Theta.
- **Policies, Procedures & Protocols (PPP)**
 - Began revising the university's student code of conduct and disciplinary process to incorporate language reflecting OVW grant expectations through Grand River Solutions consulting services.
- **Marketing & Messaging**
 - Advertised the campus advocate's services across campus in English and Spanish.

Due to the COVID-19 pandemic, as well as unexpected delays in drawing down funding at the beginning of the grant cycle and in hiring a new Project Director, we will be applying for a one-year no-cost extension, expiring in September 2024, in order to spend down remaining grant funds. We anticipate fulfilling all of the goals outlined in our Strategic Plan by the end of the requested extension.
