I, (print name) _____, a member of University of Idaho, Elmore County 4-H or FFA, fully understand the minimum weight limits of animals to be sold at the University of Idaho, Elmore County 4-H Livestock sale.

I understand that: **Beef must weigh a minimum of 1100 pounds; Swine must weigh a minimum of 220 pounds; Sheep must weigh a minimum of 105 pounds; Goats must weigh a minimum of 40 pounds; Dairy-Yearling heifers must be bred and have proof of breeding to sell if old and big enough per breed..**

I agree that if my animal does not meet the minimum weight at fair weigh-in or dairy heifer is not bred I can show my animal in showmanship and feeder quality class.

I agree to attend at least six (6) club meetings, do a demonstration, one fair grounds improvement project, one community service project, and attend a species specific educational clinic if required.

Market animals must be fed Sunday morning following the sale before being loaded on the truck. **I will make sure my animal is fed and watered by 5:30 a.m. Sunday morning.** All non-sale animals must remain on the fairgrounds until Sunday. It is the member's responsibility to remove all non-sale animals from the fairgrounds from 6:00 a.m. until 2:00 p.m.

I will clean my animal's pen by Sunday, 2 p.m. If I fail to do so, I will be charged \$25 per animal cleaning fee for someone else to clean the stall.

I certify that all drugs and feed additives received by my animal have been used in conformity with the feed or drug manufacturer's directions and comply with withdrawal times as required by the Food and Drug Administration. If I am in violation of this directive, my animal WILL NOT BE SOLD AT THE ELMORE COUNTY FAIR 4-H LIVESTOCK SALE.

Idaho Youth Livestock Program Commitment to Excellence

I believe that participation in the Idaho Youth 4-H Livestock Program should demonstrate my own knowledge, ability, and skill as a feeder and exhibitor of livestock.

I will do my own work to the full extent of which I am capable and otherwise will only accept advice and support from others.
