They also want to provide an example for others to continue giving to the University of Idaho and helping students reach their dreams and goals.

# **Purpose**

It is intended that the *Mike and Patty Fery Scholarship Endowment* be awarded annually to at least one deserving student in accordance with the award guidelines, selection criteria, and selection procedures set forth below. If the selection criteria expressed below are at any time in the University of Idaho's sole determination unenforceable or unlawful, then the University shall make awards without regard to such criteria but otherwise in accordance with the donors' more general purpose of providing student scholarships.

# Award Guidelines

- 1. The number of scholarships awarded each year, and their amounts shall be dependent on the annual earnings generated by the endowment. As the endowment earnings grow, the number of scholarships awarded each year and/or their amounts may be increased.
- 2. Scholarships may be used for educational expenses including, but not limited to tuition, fees, books, and room and board.
- 3. The scholarship shall be awarded for one year only; however, the recipient may receive this scholarship in subsequent years if they continue to meet the selection criteria.

### **Eligibility Criteria**

- 1. Recipients shall be enrolled in a degree-seeking program at the University of Idaho.
- 2. Priority will be provided to students who:
  - a. Demonstrate financial need as determined by Student Financial Aid Services
  - b. Have a learning disability with preference given to Dyslexia and ADHD
  - c. Graduate from smaller high schools
