- 1. Thank you to those who are willing to help with the weigh-ins. It is appreciated. Swine weigh-in numbers.
- 2. Dairy enrollment deadline is Friday, April 28th. Bill of sale/brand inspections are due as well as the Market Animal Agreements.
- 3. Dairy weigh-in is Friday, May 5<sup>th</sup> from 6:00 to 7:30 p.m.
- 4. Dairy presentation dates are July 10<sup>th</sup> and the 17<sup>th</sup> starting in the afternoon. If youth cannot attend either of those days, contact the office for a make-up date.
- 5. Sheep enrollment deadline is Monday, May 8th. Bill of sale/Cool forms are due by May 8<sup>th</sup>. Weigh-in is Tuesday, May 16th from 6:30 to 7:30 p.m.
- 6. Sheep superintendent, Kirbi Sharp will be holding a "first timers" sheep meeting at the office, on May 1st at 6:00 p.m.) Please see flyer. Please encourage all of your new sheep families and those who are interested, to attend. Will cover penning, animal care, show expectations, etc.
- 7. Also, Goat, Turkey and Rabbit enrollment deadline is Monday, May 8<sup>th</sup>.
- 8. Turkey bills of sale are due May 25th. Due to delivery issues for turkeys, the purchase date has been extended to the 30<sup>th</sup> of April.

- -Also, write down suggestions and changes for next year and talk to superintendents so they can be presented to the livestock committee in the fall.
- 11. Ryan Taylor-parking plans for fair. Instead of parking trailers in the back lot, they will need to be parked on 5

acres that the city owns south of the Wastewater Treatment Plant on Hiland. The county has permission from the city to use the lot just before and after the fair for livestock trailers and semis for the rodeo. They will have some sort of security. Clubs must choose how to get feed from the trailers to the animals-please note that side-by-sides without proper registration can be ticketed for driving on city streets. In the 4-H lot at the fairgrounds, the white gate at the back is for emergency access, even if it is locked, **and can not be blocked ever!** There could be one way traffic to get onto Hiland-vehicles will have to go North to reduce congestion at Hiland and Highway 30/Main Street.
