Per Fair regulations, exhibitors must be enrolled and paid with either 4-H or FFA in Latah County to participate in the Fair. Sara has also been in contact with the Whitman Cty Extension they will make every effort to help their members. Latah County should not have any Whitman Cty members entering our Fair.

# Latah County 4-H and FFA Large Animal Round Robin Contest

- 1. 4-H participants in the Round Robin Contest must be 8 years old by January 1<sup>st</sup> of the fair year.
- 2. There will be a maximum of 2 showman per species.
- 3. 4-H and FFA will be judged separately.
- 4. The Grand Champion Showmen for the following species will be eligible for the Round Robin Contest: Beef, Dairy, Goat, Sheep, Swine, and Horse. Excludes Pack Goat
- 5. If the Grand Champion Showman chooses not to participate, the eligibility will then go to the Reserve Showman for the species, and if needed to the Bronze Showman for the species. The horse Showmen will give notification by August 1<sup>st</sup> if they will or will not participate. Written refusal form will be provided by the Extension office.
- 6. If a showman is eligible to participate in the Round Robin competition with more than one species, the showman must declare one species. The species declined shall have its representation determined by rule #5. Should a showman who is a dual-member of both 4-H and FFA qualify with two different species, they are eligible to participate in the contest with both species.
- 7. All eligible participates will begin the contest by showing their own animal and rotate clockwise. If barn superintendent, 4-H Extension personnel, FFA advisor, or Horse Leader feel an animal is being stressed they will decide the replacement animal(s).
- 8. Each species will be shown for 7 minutes. Each Showman will show all species, using correct showmanship techniques for each. All competitors will be showing at the same time.
- 9. Animals will be shown in a central arena, if possible. Fair management is responsible for arena set up.
- 10. There will be 1 (one) judge for each species, someone not from our county, is preferred. The judge(s) will have knowledge about the species and the correct way that species is to be shown. A volunteer will hold animals when participates rotate. The volunteer will be selected by management.
- 11. The judge(s) will score the Showman on a scale of 1 to 10. One being the lowest and ten being the highest. Showman with the highest total points after showing all species will be the Overall Grand Champion. Two (2) awards will be given out, 1 (one) to 4-H and 1 (one) to FFA. Awards purchased and provided by the Fair board.
- 12. Showman will be judged Olympic style: Meaning individuals are scored against their own ability, they are not judged against the other showman.
- 13. The judge may ask the exhibitors to switch animals during the course of each species being shown.
- 14. In case of a tie, the Showman will be given a question by the judge, on any species shown during the contest. Exhibitors will have 30 seconds to answer the question.
- 15. A Showman may participate in the Round Robin Contest each year they qualify.
- 16. The judge's decision is final.

**Latah County Market Animal Sale Report**: No one from LMAS present for a report. Jim mentioned that the sale will take place outside in the Sheep Arena and LMAS is also trying to incorporate an online component. August 3<sup>rd</sup> is the next meeting. Kim asked if proxy buyers would be allowed, need LMAS to confirm.

#### **Old Business:**

- Herdsman Award Tammy reported two sponsors for the Award: R & R Saddle & Switch and the Tammy
  Johnson Family (THANK YOU). Wording on the award will be "Top Daily Herdsmanship Award". The award is for
  the whole barn, not per club. Parameters are cleanliness, presentation, education materials, and relating to the
  public. This year will be different due to the nature of the Fair as all barns will be closed during the show and clubs
  will be encouraged not to decorate. Judges will be chosen by Sara. Kim would like Sara to add to the newsletter
  in early August to go over the rules and the award parameters.
- Tammi still working on the banners for pictures. 2 x 4 = \$12.94, 4 x 6 = \$30.81 plus shipping and handling. She will get with Sara on the use of the 4H logo. We are still a go for these banners at the Fair per Jim.

# **New Business:**

- Sara reported on the weigh-in report (4H & FFA): Market Beef = 38, Sheep = 19, Market Goats = 10, Swine = 173
- Masks are mandated in Latah County, therefore required during the Fair. Please get the word out for families to come prepared as the County will not provide masks.
- New Fair theme: "A Fair Like No Other". Forms are still due August 1st. Jim needs to know ASAP and will still enforce the \$25.00 late fee. Fair Board meeting on August 3rd to report on numbers. Jim will offer refunds if the Fair is cancelled. Online payment is quicker for refunds than check payment. Jim also reported that the Fair has lost quite a bit of revenue this year (year-to-date loss of revenue of \$75,000.00) and are actively seeking sponsorship pdf form can be found on the website.
- Jim reported that 56 new swine pens have arrived and the entrance into the wash racks (Beef and Swine) is being redone.
- Audience will be limited to families of members showing in the Swine Arena as the show will take place in the barn and not outside. Please ask extended family to stay home. It was suggested to move the sheep inside and move the swine outside based on swine/sheep numbers. Jim will discuss this at the next Fair Board meeting.
- Camper parking set for Saturday, September 12<sup>th</sup> first come, first served.
- The middle swine pens still need to be put together for shelves and backing for stall cards.
- Sara does not feel comfortable holding the Livestock Judging Contest, it will be cancelled for this year and the county requirement will be waived. Stephanie asked Kim about the tie breaker for County Awards will need to use something different, perhaps record books. Will need to be discussed further.
- Tina asked about barn duty expectations in the Sheep/Goat barn. It was discussed that this is a barn superintendent duty and each barn is different. The sheep/goat barn has a sign-up sheet for duty for the entire barn, not per club. Jim mentioned a meeting with the barn super during Fair to clear up confusion.

#### **New Business:**

Fair 2020:

Total of 234 members completed for a total of 273 projects. This number is down from previous years. Round Robin: went great, nice format, completed in under 1 hr.

Concern was raised on show attire. Sara will communicate in newsletter and to leaders the expectation. However, monitoring would not be a practical use of resources and very open to interpretation. Dress code is enforced only for the safety aspect of members at this time.

- The swine barn superintendent requested a list of club leaders/project leaders and phone numbers to have during the Fair in case of emergency in the barn. Sara was instructed to give this info out to all barn supers as this is a good practice.
- The Dairy show was held September 27<sup>th</sup> at the U of I parking lot. 4 members participated.
- U of I will be hosting a Virtual Carcass Contest the week of October 19th. Sara will communicate more details as they become available to members/leaders.
- There was some confusion (and heated argument) on scrapie tags between a parent and the barn super. Issue is now resolved. Sara does not want barn supers to deal with angry parents wants them to direct the issue to either the Fair Board or herself.
