Based in Boise, the University of Idaho James A. and Louise McClure Center for Public Policy Research addresses policy issues of importance to Idaho and the region. The McClure Center produces independent, neutral research with integrity.

Over the past 15 years, the McClure Center has heightened public discourse around policy making, published evidence-based research that contributes to a strong democracy, engaged students in learning about public policy making, and championed a collaborative approach to tough problems.

The McClure Center is honored to be part of the University of Idaho's 130-year legacy of leadership, grounded in the land-grant mission.

Looking ahead, the McClure Center will continue to define new standards of excellence and impact in Idaho and beyond.

This includes expanding capabilities in economic analysis; adding student programs, such as opportunities for Vandals in Idaho's capital and the nation's capital; increasing trainings that focus on connections between science and policy; returning to the annual McClure Symposium on Science and Public Policy; and building on collaborative engagement practice.

As well, the McClure Center is dedicated to securing additional financial support through federal and state grants and foundations, which are essential for growing the number of McClure Center staff and students and university partners.

This strategic plan provides a high-level overview of impact areas that will propel the McClure Center's mission and vision forward over the next five years.
