HOUSE BILL NO. 111

BY STATE AFFAIRS COMMITTEE

AN ACT

RELATING TO mandatory drug tests for all Idaho high school students.

Be It Enacted by the Legislature of KYG:

SECTION 1. That Section 11-1111, Idaho Code, be, and the same is hereby amended to read as follows:

Section 1: All Idaho high school students shall participate in mandatory drug tests

Section 2: Testing will be by random selection of students every three (3) months.

Section 3: Should a student fail the drug test, parents and/or guardians will be notified and the student shall be fined one hundred dollars (\$100).

STATEMENT OF PURPOSE

RS 11111

The purpose of this legislation is to decrease drug usage in Idaho teens.

FISCAL NOTE There is no fiscal impact to the general fund.

HOUSE BILL NO. 222

AN ACT

RELATING TO maturity level ratings for school library books

Be It Enacted by the Legislature of KYG:

SECTION 1. That Section 22-2222, Idaho Code, be, and the same is hereby amended to read as follows:

Section 1: Books in Idaho public school libraries will be required to be labeled with the following maturity level, based on content: Child Safe (CS), Pre-Mature (PM), Mature (M), Mature Adult (MA).

Section 2: Content ratings of new releases will be determined by book publishers.

Section 3: Books currently housed in school libraries will be subject to rating at a local school level.

STATEMENT OF PURPOSE RS 22222

The purpose of this legislation is to give readers a chance to know what they will be reading before they procure a library book in Idaho public schools.

FISCAL NOTE There is no fiscal impact to the general fund

HOUSE BILL NO. 333

BY STATE AFFAIRS COMMITTEE

AN ACT

RELATING TO the ban of artificial caffeine in Idaho public schools.

Be It Enacted by the Legislature of KYG:

SECTION 1. That Section 33-3333 Idaho Code, be, and the same is hereby amended to read as follows:

Section 1: Concession stands in all Idaho public schools (K-12) shall be banned from selling beverages containing artificial caffeine.

Section 2: No individual shall posses artificially caffeinated beverages on Idaho public school grounds.

Section 3: Any person in possession of an artificially caffeinated beverage shall receive three (3) warnings, and shall then be fined for future infractions. Offenses after the 3 warnings shall be fined \$5, the second three offenses shall be fined \$10 for each offense, and all future offenses shall be fined \$20. The student council of each school shall enforce this statute.

STATEMENT OF PURPOSE RS 33333

The purpose of this legislation is to improve student health by removing artificial caffeine on school campuses.

FISCAL NOTE

There is no fiscal impact to the general fund. Any funds from fines shall go to the student council of the respective school district.

HOUSE BILL NO. 444

BY STATE AFFAIRS COMMITTEE

AN ACT

RELATING TO mandatory animal control facilities in every Idaho County.

Be It Enacted by the Legislature of KYG:

SECTION 1. That Section 44-4444, Idaho Code, be, and the same is hereby amended to read as follows:

Section 1: All Idaho counties shall be required to have a pound, animal control facility, or humane society.

Section 2: The facility will be placed in the most populated city or county seat or other location as determined by the County Commissioners.

Section 3: Decisions for animal placement, treatment, adoption, etc. shall be made at the county level by the local animal control facility.

STATEMENT OF PURPOSE RS 44444

The purpose of this legislation is to provide for proper care and treatment of animals by professional staff.

FISCAL NOTE

Counties shall be held responsible for funds required to create and operate animal control facilities.

HOUSE BILL NO. 555

BY STATE AFFAIRS COMMITTEE

AN ACT

RELATING TO mandatory drug testing for teenage employees in Idaho.

Be It Enacted by the Legislature of KYG:

SECTION 1. That Section 55-5555, Idaho Code, be, and the same is hereby amended to read as follows:

Section 1: All individuals under the age of 20 who are working in Idaho shall have a mandatory drug test prior to being hired at any job supported by tax dollars.

Section 2: Drug tests will be provided by employers and will be given at the employer's discretion. In addition, employers hold the right to hold random or monthly tests through the individual's employment.

Section 3: If an employee fails a drug test, they have one (1) week to retake and pass the test. A second failing result will be recorded on the employee's record. Future failed drug tests will result in progressive fines. Five (5) failed drug tests within three (3) consecutive years will result in automatic termination.

STATEMENT OF PURPOSE RS 55555

The purpose of this legislation is to prevent illegal drug and alcohol usage in the workplace.

FISCAL NOTE

The fiscal impact to the general fund is unknown at this time as the number of drug tests that will be required is unknown at this time.

HOUSE BILL NO. 777

BY STATE AFFAIRS COMMITTEE

AN ACT

RELATING TO Mandatory participation in extracurricular activities for Idaho public school students.

Be It Enacted by the Legislature of KYG:

SECTION 1. That Section 77-7777, Idaho Code, be, and the same is hereby amended to read as follows:

Section 1: Students shall be required to take part in a minimum of four (4) extracurricular activities during their high school career.

Section 2: Students shall take part in a minimum of one (1) extracurricular activity per year.

Section 3: Extracurricular activities include any sports and/or clubs endorsed by the school.

Section 4: If a student fails to meet these requirements, the student must perform five (5) hours of community service prior to receiving their high school diploma.

STATEMENT OF PURPOSE RS 77777

The purpose of this legislation is to increase participation in extracurricular activities in Idaho high school students.

FISCAL NOTE There is no fiscal impact to the general fund.
