| Are there services covered before you meet your Deductible ? | Yes. Pharmacy, services that require Copays or In-Network immunizations and Preventive Care are covered before you meet your Deductible . | This Plan covers some items and services even if you haven't yet met the Deductible amount. Does this plan provide Minimum Essential Coverage? **Yes.**
