Course Introduction

Rock and roll is one of the greatest cultural legacies of the 20th century and its influence on our lives cannot be overstated. It is a kind of music that has developed strong roots not only in the United States but in many other countries as well. It encompasses dozens of different styles and it continues to evolve to the present day. You will learn about rock by reading the chapters in each unit and listening to the examples and recommended listening that accompany each chapter. Approximately every three chapters there will be a lesson with some questions for you to answer taken from the material included in the reading assignments. At the end of each of the four units, you will take an exam that will include both written and listening sections. Finally, you will complete two written assignments that will give you an opportunity to go into some depth.

Course Objectives

There are three primary objectives in this course. The first objective is to provide you with an understanding of the chronology of rock music. The second objective is to give you an understanding of

the characteristics that differentiate one style of rock from another. The third objective is to create an understanding and appreciation for the influences that often connect artists and musical styles.

Lessons

Projects

This course requires you to complete two projects which will give you an opportunity to develop necessary skills to achieve course goals of 1) developing the ability to communicate your knowledge and opinions about music articulately and 2) understanding chronology in rock music, style characteristics, and influences.

Exams

- You must wait for grades and comments on assignments prior to taking subsequent exams.
- For your instructor's exam guidelines, refer to the *Course Rules* in Canvas. Refer to *Grading* for specific information on assignment/exam points and percentages.

There are four exams as part of this course. Each exam covers one unit (three lessons) and includes short answer, essay, and listening components. One exam is to be taken at the conclusion of each unit.

Course units: The class is divided into four units that are further subdivided into chapters. Click on the Course Units below or in the menu on the left to view each unit. To really get the most from this class you need to read all of the text, view every video clip in its entirety, and follow the suggestions for further listening. If you find a topic that really interests you, go the extra mile and watch a film that I recommend to get more depth on the subject.

Lesson 1 Basics, Rhythm and Blues, the Independent Labels and Elvis Presley

Lesson Objectives

The purpose of this lesson is to familiarize you with some basic music terms, to introduce you to some of the styles that preceded rock and roll, to acquaint you with the state of the recording industry around 1950, and to explain the significance of Elvis Presley to the emergence of rock music.
