

K12 Education How-To Claim Continuing Education and Professional Development Credits



ECHO Idaho provides high-quality, easily accessible, relevant, and <u>free</u> continuing education and professional development for health care professionals and educators in Idaho. This guide is intended to help you claim the type of credit that fits your professional role.

Credit Types Explained

Dual-licensed professionals seeking Continuing Education (CE/CME):

All Pupil Service Staff in Idaho are required to complete six credits for certification renewal or provide a current occupational license issued by the appropriate Idaho state licensing board to the State Department of Education. For participants seeking credits to apply to their healthcare license refer to ECHO Idaho's Continuing Education page for additional information regarding CE/CME credits by profession. Claim credit for attending any of ECHO Idaho's sessions.

Professional Development (PD) Credit for Educators:

Participation in 15 live and/or asynchronous sessions is equivalent to one (1) semester credit hour. Participants will have the opportunity to earn two (2) semester credit hours by attending 30 sessions. Credits are offered in partnership with the College of Education, Health and Human Sciences and will be transcribed through the University of Idaho. Please follow the steps below for this type of credit.

Note: Participants seeking PD for educators must complete all steps below no later than 7/1/2024.

Step 1. Registering with ECHO Idaho

Please register here. During registration you will select the series you are interested in attending – see below**. Once registered you will receive day-of-session emails that contain session information, a zoom link to participate, and information for claiming PD credits for Educators and CE/CME credits for dual-licensed professionals. You can also opt to receive a weekly digest email that has information on how to join all the sessions going on during the upcoming week.

Step 2. Participating in sessions and claiming credit

Participate and claim credit two different ways:

- A. Join a live session (synchronous learning) using the zoom links provided in ECHO Idaho's emails, and/or
- B. Watch recorded sessions (asynchronous learning).

ECHO Idaho uses <u>eeds</u>, an online Continuing Education (CE) management application, so that ECHO participants can claim credit for both.


Following a live session (synchronous), follow these steps to claim credit in eeds:

- A. In the day-of emails and throughout each ECHO Idaho session, you will receive an eeds **Sign-in Code** specific to that day's session. On the <u>eeds sign-in page</u> and use the sign-in code:
 - You will be asked to provide an email and verify your last name.
- B. Once signed in, claim CE by selecting **Complete Course Evaluation** in the To-Do list (or under "What would you like to do now?" See asynchronous sessions below).
 - Note: The CE certificate will not be available until the course evaluation is completed.
- C. Download and save your certificate.
 - Select View/Print Attendance Certificate from the To-Do list (What would you like to do now?), digitally sign and specify the amount of credit you are claiming. For educators you must have attended the full hour of the session to claim credit and will therefore report 1.0 in this field.




Receiving credit for watching asynchronous ECHO sessions, follow these steps:

- A. While participants are encouraged to attend live sessions, all K12 Education sessions will be recorded and available upon request by email. Please email echoidaho@uidaho.edu and ask for information about accessing ECHO Idaho's K12 Education recorded sessions.
- B. ECHO Idaho will email you a document with links to recorded sessions as seen below.



C. In eeds, click on "Continue to Enduring Materials."



- You will be asked to provide an email and verify your last name and then be directed to the video to view.
- D. View the recorded session and acknowledge viewing of recorded session using the post-test attestation of watching the recording.
- E. Follow steps B & C above from "Following a live session" above to download and print your certificate.

Step 3. Applying for Professional Development Credit

After completing fifteen (15) sessions from any of the K12 Education series (either live or asynchronous), you are eligible to receive one (1) semester credit hour (or two (2) semester credit hours by completing 30 sessions). Credits will be transcribed by the University of Idaho.

Complete <u>this form</u> to indicate the sessions you have attended. ECHO Idaho staff will verify your attendance and survey completion. Once attendance and survey completion has been verified, you will receive an email with a promotional code and final instructions on how to claim your credit via the University of Idaho.
