## Minutes for Latah County Horse Leaders Meeting October 16<sup>th</sup>, 2006

**Present**: Gail Silkwood, Jane Allenby, Beth Cree, Bev Hunter, Debbie Lawrence, Leona Svancara, Kerry Thompson, Susan Clary, Lisa Allenbach, Extension Educator- Mauri Knott, Guests- Anita Fallon, Ty Svancara.

Meeting was called to order at 6:05pm by President Susan Clary.

**Minutes** for the last meeting were read by acting by acting secretary Bev Hunter Kerry moved the minutes be accepted as read, Leona seconded-motion passed. Copies of these minutes will be available at the next meeting.

**Treasurers Report** by Treasurer Debbie Lawrence: Camp \$583.62; Drill Team \$465.50; General \$1150.25; Helmet \$50; Model Horse \$145.50; Travel \$557.86 **Total \$2952.73.** Bev moved the Treasurers report be accepted as read, Leona seconded-motion passed. The counties share of the District Horse Show is still not paid. An itemized bill has not been presented. The original bill was for \$41.51 but at the District Leaders meeting it was approximately \$52. We are still waiting for an itemized bill.

#### **Old Business:**

District Horse Leaders Meeting: Bev and Gail attended along with Amy Wood. All the changes to the District rule book requested by Latah County were denied. Lots of discussion about award quality at the district show and the fact that youth are choosing to go to other shows with better awards. Nothing will be done at District level to improve awards. Awards are up to the hosting County. (Latah County might want to try to increase participation among their eligible youth by providing incentives such as travel grants, County High Point award based on County and District show, etc. Everyone should think about this.) Discussion about the terms "western hat" and "cowboy hat" re: District rule book. Discussion about "Fat Baby" type boots. They are not meant for riding, having a thick crepe sole. District Leaders voted to make them illegal for riding. The exact wording for the rule change is not determined. Jim will consult with Wyoming extension about the wording they are using to make them illegal.

State Horse Leaders Meeting: Meeting was in Orofino on October 13<sup>th</sup>, 2006. Mauri, Gail and Susan attended. There were 12 leaders and 3 Extension staff at the meeting. Idaho is thinking about adopting the *Pacific Northwest 4-H Horse Project Manual*-this is a "How-to" not a rule book and the *4-H Horse Contest Guide* –this is a rule book. (attendee's received copies of both documents PNW 587 and PNW 574). Horse would become a state wide project with uniform rules rather then county and district rules if the contest guide is adopted. Discussion about a state Junior Horse Bowl was sent to committee. Expect to hear more about this in 2007-2008. There was discussion about District #4's late entries into state contests. Suggested late entries are not accepted. The 2007 state contests will be hosted by Kootenai County in Couer d'Alene. They will be July 9<sup>th</sup> and 10<sup>th</sup>, 2007.

County Horse Show Date Change: Reasons to change- hot; short practice lead time to District Show; it is right after 4-H camp. After looking at schedule there are know "good" alternative dates. People should think about this to see if there is a way to address all the concerns.

County 4-H Horse Show – July 21 & 22, 2007 – Same committee as Open Show.

New Manual: (also see the discussion under State Horse Leaders Meeting regarding PNW 587) Pacific Northwest 4-H Horse Project Manual. Idaho is thinking about adopting this publication to replace the publications we currently use. This is the "how to "book. This is a first Draft form and there are a couple of typos that would require correction labels. On page113 the line between the front and rear of the horse would be moved to go through the withers not the middle of the horse's barrel. On page 135 obstacle 9 looks like the raised poles are inserted into holes rather then resting on top of the side boards, this would be clarified. Please look at the publication and see what you all think. Look for changes that should be made. Fresh eyes are needed.

**New Contest Guide**: (also see discussion under state Horse Leaders meeting regarding PNW 574) Idaho is thinking about adopting this manual as a state wide set of rule for horse contests it would replace district and county rules or at least be the "umbrella" set of rules. Again look at it and see what you think.

**Danish System:** Susan and Gail attended the Pacific Northwest 4-H Horse Judging School. This school is put on to train judges about the Danish System and 4-H rules as included in the PNW574 publication *4-H Horse Contests Guide*. Washington and Oregon currently use this publication if Idaho adopts it we need to really educate our youth/leaders/parents as to what the Danish system means. Essentially white is good not bad. Mauri would like to have a class during Leaders Training this year that covers the Danish system. We would not be required to use only judges that had graduated from the PNW 4-H Horse Judging School if Idaho adopts the *PNW 4-H Horse Contests Guide*.

Debbie Lawrence raised the idea of putting on an adult only horse camp, perhaps as a fund raiser. This is especially pertinent as we have filled the horse camp with youth and no longer have an adult group. It was pointed out that we need to educate the leaders and parents as well as the youth.

**Secretary-** Bev nominated Beth Cree, Beth declined. Kerry nominated Bev Hunter, Leona seconded, no further nominations. Bev Hunter is the new Secretary

**Vice President** – Kerry nominated Beth Cree, Debbie seconded, no further nominations. Beth Cree is the new Vice President.

**President** – Kerry nominated Susan Clary, Leona seconded, no further nominations. Susan continues as President.

There was discussion about the Idaho Horsemanship Award, the 2007 Idaho Youth Horse Contests held in Couer D' Alene in July, possibly adding a hippology contest next year, review of the PNW Horse Manual again – which should be implemented in October 2008. There was discussion of rule changes, CCS Books, removal of the Saddle Seat class from District show class list. Mauri reported that the District 1 4-H program staff and extension educators will be meeting on November 15, one of the proposed agenda items is the efficiency of the District Horse Leaders. Rule book changes will be incorporated and printed by the January meeting.

State Horse Leaders (Idaho Youth Horse Council): This meeting was held on October 5 in Boise. Discussion topics included junior horse bowl & hippology contests at the 2008 Idaho Youth Horse Contests. Mauri reported that the Idaho Youth Horse Council is currently designed to be an advisory board for all youth horse organizations — pony club, 4-H, youth breed associations, etc., it is not currently organized that way as only 4-H is represented. Carrie Stark, the new state 4-H specialist for animal science and shooting sports, is currently looking into ways to make this organization more effective and well represented.

#### **New Business:**

**07-08** Events: Treva Beebe, owner of Equine Athletics has offered the use of her facility to host a series of equine clinics for 4-H kids. There was consensus from the group not to add that to our 2008 events at this time. *Horse Camp*: Bev attended the Pony Club planning meeting and horse camp will be June 12-15. This will overlap for swine weigh in on June 13.

### **New Business Continued:**

District Horse Show: It has been requested that Latah and Nezperce Counties co-host District Show this year (August 2, 2008). Bev moved and Lisa seconded to co-host the District Horse Show. Unanimous approval, motion passed. Mauri will work with Kerry in Nezperce County to be sure that each county has clear roles and responsibilities for the event. The group agreed to host an open show on August 3<sup>rd</sup> as well. It has been suggested that Kootenai County host District Horse Bowl, however that has not been decided yet.

Officer Elections: Treasurer: Bev Hunter; Secretary: Gail Silkwood; Vice-Chair: Leona Svancara; Chair: Debbie Lawrence; Horse Show Committee Chair: Susan Clary. It was suggested to make the Horse Show Committee Chair an elected position each year to be sure we host organized horse shows. This will be addressed at our next meeting. Debbie questioned rule book changes as one was proposed at our previous meeting. Mauri will get the exact wording regarding change of the horse show date verbiage emailed out to everyone next week to be voted on at January meeting.
