### SEEP RECERTIFICATION

#### 3 Year Renewal Requirement

A Recertification Application must be renewed every three years. The certificate holder must:

- Abide by the SEEP Code of Conduct
- Accumulate 10 Continuing Education Unit points during the three-year period. Complete and submit the Recertification Application documenting CEU points to SEEP Steering Committee.

#### How to Acquire Continuing Education Units:

Unit Type	CEU Description	Points Per Unit
EDUCATIONAL PROGRAMS	Attend educational programs: <ol style="list-style-type: none"> <li>1. Stormwater and/or erosion control seminars or webinars</li> <li>2. Regulatory sessions relating to site disturbance ordinances</li> <li>3. Water quality conferences</li> <li>4. Similar programs</li> </ol> Submit program agenda or website and one paragraph describing educational program, include lessons learned, take away points, or action steps.	1-3 hours= 1 point 4-6 hours= 2 points >6 hours= 3 points  7 points maximum
HOME STUDY	Read articles on related topics or watch relevant online videos. Submit title, date of article, website link, and a one page description of content.	1 point per article  5 points maximum
PUBLIC SERVICE	Give a presentation to a group (any group) on related topics: <ol style="list-style-type: none"> <li>1. Erosion Sediment Control (ESC)</li> <li>2. Planning for ESC</li> <li>3. Stormwater</li> <li>4. Water Quality</li> </ol> Submit presentation outline or copy of presentation to SEEP committee	3 points per presentation  6 points maximum
SEEP RELATED MEETINGS	Attend SEEP Board meetings or IDEQ Watershed Advisory Group (WAG) meetings.	1 point per meeting  7 points maximum
JOB EXPERIENCE	Submit photos of successful BMPs on your job site OR submit evidence that an ESC plan designed or installed by you was approved for use by a regulatory agency.	1 point per submission  3 points maximum
SEEP CLASS	Attend or instruct SEEP Basic Class (re-testing not required) or SEEP Recertification Class.	1-3 hours= 1 point 4-6 hours= 2 points >6 hours= 3 points  10 points maximum
