

Prohibited Items

The following items are not permitted inside Albertsons Stadium. This is not a comprehensive list and any item deemed inappropriate or dangerous may be disallowed.

- Weapons
- Explosives
- Alcohol
- Artificial noise makers (blow horns, air horns, cow bells, megaphone, etc.)
- Outside food & drinks
- Any glass or plastic containers
- Large bags, backpacks, or wheeled/hard-sided bags
- Umbrellas, coolers, baskets
- Long lensed cameras (removable lens larger than 4 inches)
- Tripods, tape recorders, video recorders
- Electronic transmitting devices
- iPads, tablets, laptops
- E-Cigs
- Selife sticks
- Seat cushions with arms
- UAS, RCMA, UAV or Drones

Any items left at entry gates will be discarded.

A bag check is available on both the east and west sides of the stadium for guest with prohibited bags. Illegal or dangerous items will not be accepted at check in locations.

No Drone Zone

Operating a UAS/RCMA/UAV or “Drone” is prohibited on or over the entire Boise State University campus on home football game days per Boise State policy.

Anyone found to be operating a drone in violation of Boise State policy is subject to exclusion by campus security officials.

Smoking

Smoking is not permitted anywhere on Boise State. Electronic cigarettes or any other “vaping”.

Stadium Seat Back Policy

Seatbacks are limited to 18 inches wide without arms. Permitted seatbacks are available for rent inside the stadium gates.

Lost Children

Stay with the child or reporting party. Contact your supervisor and provide a description of the child including last known location. Do not leave the child or reporting party for any reason until the family/child is located.

Medical

Aid stations are located on the west side of the stadium on the 2nd level (concourse) near the elevators as well as on the east side of the stadium on the lower level behind the student sections.

Contact the command post for medical response.

Suspicious Persons and Packages

Report any suspicious or unattended packages, backpacks, or items to security and law enforcement. DO NOT TOUCH any suspicious or unattended items. Report persons displaying suspicious behavior to security or law enforcement. Some examples of suspicious behavior or activity include:

- Recording/monitoring/taking notes of sensitive areas or procedures.
- Persons not fitting the baseline of normal activity or attire.

Report any attempts to penetrate or test physical security procedures as well as abandoned or illegally parked vehicles.
