Intercollegiate Athletics Agreement

This agreement by and between California State University, Bakersfield Athletics (Home Team) and University of Idaho (herein called Visiting Team) stipulates:

1. SPORT: Men's Basketball  
DATE: December 11, 2021  
TIME: 7:00 PM  
SITE: CSUB Icardo Center  
TICKETS: 50
2. The contest shall be governed in all respects, including the eligibility of the participants, by the rules and regulations of the NCAA or any conference or association to which either or both of the parties may be affiliated.
3. Officials shall be appointed by the Home Team institution unless otherwise specified.
4. No radio or television broadcast or cablecast shall be done without permission of the host school.
5. The financial considerations (i.e. guarantee, entry fee, etc...) shall be specified as: CSUB at University of Idaho November 16, 2022, with the option to change the date.
6. The contest(s) shall only be cancelled or dates changed by mutual consent of the contracting parties. The parties shall be relieved of their duties hereunder only in the event of extraordinary circumstances beyond the control of the party seeking cancellation, including weather, malfunction of equipment or facilities, travel carrier cancellation, strike, civil disorder, force majeure, or similar act of God. The Parties acknowledge that the future impact of COVID-19 is not currently known or reasonably foreseeable. In the event that circumstances related to COVID-19, or to any reoccurrence of the COVID-19 outbreak, prevent, hinder, or delay a Party from performing its obligations under this Contract, the Party whose performance is affected may invoke the Force Majeure clause of this Contract and be relieved of its performance obligations hereunder, even if the circumstances related to COVID-19 were foreseeable at the time of the Parties' execution of this Contract. In the event of cancellation without such extraordinary circumstances, the team canceling the scheduled event shall pay \$40,000. If the Athletic's Director or his designee must submit a Covid-19 attestation form, it will be sent to the SWA (Cindy Goodman, [cgoodmon@csub.edu](mailto:cgoodmon@csub.edu)) via email no later than 7:00 PM on December 10, 2021


