SECOND: That the event(s) shall be scored as follows: N/A

THIRD: That the financial consideration shall be as follows:

FOURTH: That the official(s) shall be selected and paid by the home institution as appropriate.

FIFTH: That all players or contestants representing either institution in said game or meet shall be eligible under the rules and regulations of their respective institutions, conferences, and the NCAA.

SIXTH: A \$100,000 penalty for non-performance of contractual obligations, without mutual consent of both institutions in writing shall be enforced.

SEVENTH: Either party has the right to invoke force majeure and/or terminate the Agreement in the event that proceeding would be inconsistent with applicable national, state, or local health advisories and restrictions or either school's policies regarding business travel or attendance at large group gatherings, due to the global public health emergency caused by the novel coronavirus or its related illness, COVID-19. For the avoidance of doubt, a party declaring a force majeure event triggered by the new coronavirus or COVID-19 shall not be required to show that the event was unforeseeable.
