Dr. Oscar Arias Sánchez is the former President of Costa Rica and a Nobel Peace Laureate who champions such issues as human development, democracy, and demilitarization. In 1987, President Arias authored a peace plan, the Esquipulas II Accords, which ended a decades-long regional crisis in Central America. In that same year, he was awarded the Nobel Peace Prize. He has also been recognized with the Martin Luther King, Jr. Peace Award; the Liberty Medal of Philadelphia; the Jackson Ralston Prize; the Prince of Asturias Award; the Albert Schweitzer Humanitarian Award; and the Americas Award. Prior to becoming president, Dr. Arias served as professor of Political Science at the University of Costa Rica, Costa Rican Minister of Planning and Economic Policy, and Congressman. In addition, he has served on the

Commission on Global Governance, the Stockholm International Peace Research Institute, the Independent World Commission on the Oceans, and the International Olympic Committee. Dr. Arias actively participates in several international organizations including the Arias Foundation for Peace and Human Progress, the International Center for Human Rights and Democratic Development, the Economists Allied for Arms Reduction, the International Negotiation Network of the Carter Center, the Peres Center for Peace, the International Crisis Group, and Transparency International. He is also an active member of the Inter-American Dialogue, the Society for International Development, and the Create 21, Asahi Forum. In 2006, Dr. Arias became President of Costa Rica for the second time. Arias stepped down as President in May 2010.



Dr. José Joaquín Campos is the director general of CATIE (Tropical Agricultural Research and Higher Education Center), an international organization for research, education and technical cooperation based in Costa Rica, overseeing some 100 research and development projects in 17 countries in Latin America. Prior to joining CATIE, Dr. Campos worked with international NGOs on integrated conservation and development projects. He currently is a faculty member of the Graduate School of CATIE, an adjunct professor at Laval University in Canada, and a member of the External Advisory Group at the World Bank. He also serves on boards and committees for the Iberoamerican Network of Model Forests, the International Network of Model Forests, and the World

Conservation Union. Dr. Campos graduated in forestry from the University of Sao Paulo, Brazil. He obtained a master's degree in management of natural resources from CATIE, and a doctorate in forest sciences from the University of Oxford, UK.



Rula Salameh is a documentary producer and Just Vision Education and Outreach Coordinator in Palestine. She spearheaded the creation of the Encounter Point Arabic screening guide, the first screening guide of its kind in Arabic. A trained journalist by profession, Ms. Salameh covered issues pertaining to Palestinian society and the broader Middle East. She was one of the founders of the Palestinian Broadcasting Corporation in 1993, following the Oslo Agreement. She has served as the Middle East Liaison for the organization

Peace X Peace, as the Project Coordinator for Middle East Non-Violence and Democracy, and the Irish NGO Refugee Trust International. Ms. Salameh holds an international diploma in Computers in Business and Management from Cambridge International College, and attended Birzeit University in Ramallah. She is a member of the International Federation of Journalists.



Théogène Rudasingwa is the President, CEO, and founder of Haradali.org, and interim co-ordinator for the Rwanda National Congress. A medical practitioner, Dr. Rudasingwa became involved in politics, and served as the Secretary General of the Rwandese Patriotic Front in 1993 and helped stop the 1994 genocide. As Rwanda's first Ambassador to the U.S. after the genocide, Dr. Rudasingwa was the architect of post-genocide U.S.-Rwanda relations. He also served as Chief of Staff to the Vice President,

and then the President of Rwanda. Since leaving public service in 2004, Dr. Rudasingwa has worked in academia and international development. He was co-director of the University of California-Berkeley Haas School of Business Bridging the Divide program. He subsequently served as a Vice President, Pangaea Global Aids Foundation. Dr. Rudasingwa is a former Visiting Scholar at the Haas School of Business and a recipient of many awards, including the World Economic Forum's Global Leader for Tomorrow Award, and an Honorary PhD from Trinity College. Dr. Rudasingwa is a graduate of Makerere University (Medicine) and holds a master's degree from the Fletcher School of Law and Diplomacy, Tufts University.


