InSpIRE candidates have been hired in an approved Idaho CTE program and complete the program as an in-service teacher. The EPP offers a 40-hour workshop that each candidate completes before they start teaching. All of the teachers are in a clinical setting where they are supervised by a local educational leader. Each teacher is observed 4 times in the first year and 1 time in the second year. Each teacher is assigned a mentor by the school district.
