Sealed proposals will be received by the Division of Public Works, State of Idaho, at **875 Perimeter Drive, MS 2281, Moscow, Idaho 83844** until **2:00 p.m.** local time, on **Wednesday, March 20, 2024**, for **DPW Project 22252 ADA Accessible Curb Ramps, Main Campus, University of Idaho, Moscow, Idaho.**

A description of the work of this project can be summarized to include improvements to existing curb ramps on the University of Idaho Main campus in Moscow, Idaho. Work is located along 6<sup>th</sup> Street between Stadium Drive and Deakin Street for the base bid, replacing the ramps on Sweet Avenue east of Railroad Street (not including the ramps at Railroad) for Bid Alternate #1, and replacing the ramps on Sweet Avenue west of Railroad Street (including Railroad street ramps) for Bid Alternate #2.

Proposals will be opened and publicly read at the above hour and date.
