- 1. **ELIGIBILITY** The contest(s) shall be governed in all respects, including the eligibility for the participants, by the rules and regulations of the NCAA, the individual institutions and the WAC conference. In the event of any conflict in such rules or regulations; (a) if both teams are members of the same conference, the Conference rule/regulations shall control; (b) if not, or if the conference has no applicable rules or regulations, the NCAA rules/regulations shall control.
- 2. **OFFICIALS** Officials shall be selected, and all expenses paid, by the home institution, unless otherwise noted in the Special Arrangements section.
- 3. **COMPLIMENTARY TICKETS** Utah Valley University agrees to provide forty (40) complimentary tickets to the visiting team (via pass list). Pass list must be turned in to the UVU ticket office an hour and a half prior to the scheduled start time of the game to be valid.
- 4. CANCELLATION/FORFEITURE In the event that an institution shall cancel or fail to appear for the contests specified in this Agreement, the party so canceling or failing to appear shall pay to the non-defaulting party the sum of Twenty-Five Thousand Dollars (\$25,000.00) as liquidated damages for each such canceled game. Payment of liquidated damages shall be paid no later than thirty (30) days after the scheduled date for each canceled game. Cancellation or delay due to acts of God, acts of nature, or acts of any governing regulatory body, including but not limited to the NCAA or any governing athletic conference, shall not be cause for liquidated damages to be paid.
- 5. **FORCE MAJEURE -** Neither party shall be liable or responsible to the other party, nor be deemed to have defaulted under or breached this Agreement, for any failure or delay in fulfilling or performing any term of this Agreement, when and to the extent such failure or delay is caused by or results from acts beyond the affected party's reasonable control, including, without limitation: (a) acts of God; (b) flood, fire, earthquake, or explosion; (c) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot, or other civil unrest; (d) government order or law; (e) actions, embargoes, or blockades in effect on or after the date of this Agreement; (f) action by any governmental authority; (g) national or regional emergency including but not limited to epidemics, pandemics, and quarantines, such as the events connected with the 2019 novel coronavirus disease (COVID-19), including, but not limited to, illness, quarantines, travel restrictions, shelter in place orders or any other conditions that would make participation in this sporting event unsafe for either party; (h) strikes, labor stoppages or slowdowns, or other industrial disturbances; (i) shortage of adequate power or transportation facilities ("Force Majeure Event"). The party suffering a Force Majeure Event shall give as much notice as reasonably practicable of the Force Majeure Event to the other party, stating the period of time the occurrence is expected to continue and shall use diligent efforts to end the failure or delay and ensure the effects of such Force Majeure Event are minimized.
