As a follow-up to the memo, President Chuck Staben sent to Faculty Senate on May 24, 2019, I am amending the list of actions in that memo to include item 36. President Staben took no action on FS-19-070: Plus/Minus Grading prior to his last day as President of the University of Idaho on June 15, 2019. I am taking action on that item in my role as Acting President.

I have decided to disapprove the proposed change to the University of Idaho Catalog, which would include a new plus/minus grading scale. Although I realize there is significant support for this proposal among the faculty, reasonable arguments have also been made on the opposite side of the issue. In particular, ASUI leadership and many students have expressed significant concerns and reservations with the issue and are not supportive of the proposed change at this time.

I appreciate the Teaching & Advising Committee's careful work and I think this proposal could be enacted in the future with stronger support from both faculty and students. Further, I encourage involving our Office of the Registrar in such work to address the implementation challenges involved to ensure equitable treatment of our students and faculty.
