Writing Requirement:

Under the supervision of the student's LADR Emphasis Advisor, or another full-time faculty member pre-approved by the LADR Emphasis Advisors, the student must complete a significant independent writing project on a litigation or ADR-related topic. Whether written for Law 983 (Directed Study), Law 982 (Law Review), Law 981 (Critical Legal Studies Journal), Law 974 (Legal Aid Clinic), or in fulfillment of the requirements of an elective class under this Emphasis, the paper must be equivalent in length and depth to a publishable law review article. If initially prepared for a regularly scheduled paper course, the paper will require additional effort and drafts beyond that required to pass the requirements of the course for which it is submitted for a grade. LADR papers which meet the rules for the Upper Division Writing Requirement may also be used to satisfy that requirement.
