The fringe benefit rate for each type of employee uses the workers compensation rate for teachers. If you have an employee with a higher risk factor you will need to increase the rate accordingly. Be careful! The rates vary substantially.

NOTES:

Life/Disability rate of 0.68% is an estimate and will vary depending on the individual (operating budgets will be charged the actual rate on an individual basis).

Federal employees have the option of federal group life or state group life. Federal group life has numerous options and it is less expensive for the employer than stategroup life. To insure a high enough percentage to cover actual charges, the state group life insurance rate has been used.

Thrift Savings Plan has numerous rates. The most common used by FER employees is 5% therefore, 5% is used for the estimated rate; however your budget will be charged the actual rate for your employee.

Teaching & Research Assistants: Those who work during the summer but do not take classes: use the fringe benefit rate for IH Other.
Those with - non Lab at the end of their title will be classified as WC8 for Workers Compensation.
Those with - Lab at the end of their title will be classified as WC1 for Workers Compensation.
