## BEEF HEIFER REPLACEMENT PROGRAM

The Owyhee Cattlemen's Association (OCA) is interested in promoting educational and financial opportunities, related to the beef industry, to Owyhee County youth. To do so, OCA offers the Beef Heifer Replacement Program. Eligible youth can apply for, and if selected, be awarded a Beef Heifer, donated to the program by an OCA Member. Youth who participate in this program will gain knowledge and experience in selection, feeding, breeding, exhibiting, and marketing livestock. It is the intent of OCA that the youth will build their breeding herd to receive financial and educational benefits.

#### Youth Eligibility:

- 1. Youth must be in the 5th through 10th grade at the time of application.
- 2. Youth must be an Owyhee County 4-H or FFA member.
- 3. Priority will be given to youth who have not previously received a heifer from the program; however, participants may reapply if they have already been awarded a heifer.

#### Youth Requirements:

- 1. Complete and submit the application to the Extension Office by June 1 of the current year.
- 2. Have adequate facilities or a suitable location for and provide the feed to the animal.
- 3. Pick up the heifer from the donating producer.
- 4. Maintain and complete written records and submit them to the Owyhee Cattlemen's Association prior to exhibition at the Owyhee County Fair.
- 5. Attend the OCA Summer Meeting, the year of application, to be awarded an award certificate.
- 6. Attend the OCA Summer Meeting for two years after the heifer is received and present a short update on the breeding project, each year, to the OCA membership.
- 7. Exhibit the heifer as a yearling at the Owyhee County Fair, and again as a cow-calf pair the following year.
- 8. Have the female bred at the appropriate time to a quality beef bull.
- 9. Become a member of OCA.

*Note:* Heifers will be awarded, depending upon the number of applications and availability of heifers, subject to the discretion of the OCA Board.

### Heifer Eligibility:

- 1. Heifers can be purebred or crossbred.
- 2. Must be structurally sound and up to date on all vaccinations, including Brucellosis.
- 3. Must be polled or dehorned.
- 4. Must not have any sign of dairy or rodeo breed influence.
- 5. Must be open and weaned.
- 6. Females born in a set of twins with a bull are not eligible.

## **Donating OCA Member Requirements:**

- 1. Provide a Bill of Sale to youth and transfer registration papers, if applicable.
- 2. Provide heifer information such as date of birth, dam ID, sire ID, breed, weaning weight and date, and vaccination records, if available.
- 3. Provide a Bill of Sale to youth and transfer registration papers, if applicable.
- 4. Provide heifer information such as date of birth, dam ID, sire ID, breed, weaning weight and date, and vaccination records, if available.

### Additional Details:

The youth must have adequate facilities and feed for the project. The youth is responsible for getting the heifer bred to calve at an appropriate time and must have facilities for calving. Heifers should be fed for continuous growth, gaining approximately 1-2 pounds per day.

Attendance at the Owyhee Cattlemen's Association Summer Meeting and the completion of 4-H or FFA record books are mandatory. Each exhibitor must maintain written records to document the management of their heifer project.

The youth is responsible for preparing the heifer and, eventually her calf, for exhibition at the Owyhee County Fair. Participation at the Owyhee County Fair is required.

Once the youth receive the heifer, they are solely responsible for the care and management of the female. All calves the female produces will belong to the youth. If the female is sold for any reason, after all requirements have been met, the revenue generated from the sale belongs to the youth.

If the heifer dies, is unable to be bred, or is unfit for show at the Owyhee County Fair, the youth must contact OCA immediately. OCA will deal with each situation on a case-by-case basis, and the Executive Committee will make all decisions.

If the youth neglects to maintain their part of the contract, the heifer may be returned to the donating producer. In this case, the youth will be ineligible to apply for the program again in the future.

#### Program Calendar:

Year One:

- June 1st Applications due to the Owyhee County Extension office
- June OCA Committee reviews applications and conducts interviews
- July Heifer Certificates awarded to youth at OCA Summer Meeting
- Fall Youth pick up awarded heifers from producers

Year Two:

- July Submit required records to Extension Office
- July Present project update to OCA membership at the OCA Summer Meeting
- August- Exhibit bred heifer at the Owyhee County Fair

Year Three:

- July Present project update to OCA membership at the OCA Summer Meeting
- August Exhibit cow/calf pair at the Owyhee County Fair


